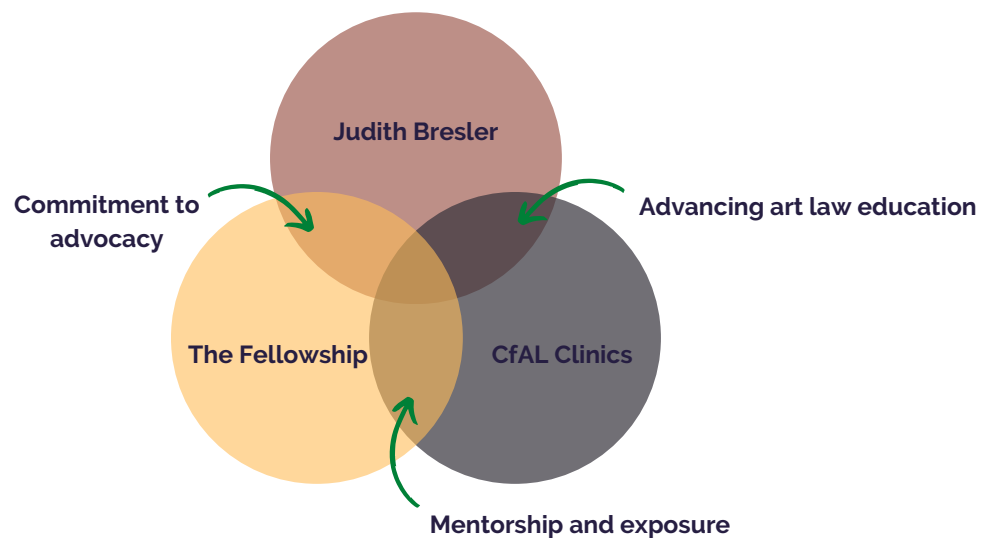


THE JUDITH BRESLER FELLOWSHIP MISSION

In 2020, with the passing of Judith Bresler, a prominent attorney and educator who co-authored the seminal "Art Law" treatise, the art law community lost a prominent and beloved colleague. Judith was a tireless advocate for the advancement of art and law and an inspiration to her colleagues and to all seeking to dedicate themselves to the practice and advancement of art and law.

In memory of Judith Bresler, the Center for Art Law is proud to offer the Judith Bresler Fellowship to candidates who exhibit many of the gifts, qualities, and passions that Judith so beautifully embodied.

Along with a desire to forge meaningful connections between law and the arts, the Center is committed to educating visual artists and the attorneys who defend them. In recognition of the numerous contributions that Judith Bresler made to advance the art law field as a lawyer, professor, author, mentor, and advocate for the arts, the Center is offering the Judith Bresler Fellowship to recent law school graduates.

VISUAL ARTISTS' LEGAL CLINICS

The Center for Art Law launched its Visual Artists' Legal Clinics in 2020, sharing informational resources and offering pro bono consultation to artists, covering topics related to immigration, legacy and estate planning, and artist-dealer relations. Pursuant to the Center's objective of making art law accessible to practicing artists, clinics have become a seminal part of its offerings for the art and law community.

The Judith Bresler Fellow leads the operation of the Visual Artists' Legal Clinics by planning each clinic session and organizing workshops and panels related to the clinic themes. The fellow further creates a network of resources to promote and expand the mission of the clinics while working with volunteer attorneys, clients, stakeholders, and related organizations on offering relevant and timely pro bono clinical sessions.

The **Visual Artists' Immigration Clinic** is designed to guide international artists through the US visa application process. The Clinic provides visual artists with an opportunity to discuss their eligibility for an artist visa with an experienced attorney.

The **Artist-Dealer Relationships Clinic** helps artists and gallerists negotiate effective and mutually-beneficial contracts. The Clinic provides a platform for artists and dealers to learn about the law governing artist-dealer relations and how to effectively negotiate contracts and consignment agreements.

The **Artist Legacy & Estate Planning Clinic** connects artists, estate administrators, attorneys, tax advisors, appraisers and other experts to create meaningful and lasting solutions for expanding the art canon. Significantly, the Clinic helps artists navigate the legacy and estate planning process.

Patrick launched the **Art & Copyright Law Clinic** in April 2024. Sensitive to the concerns many artists have raised about how to protect their copyright, particularly with respect to emerging technologies, such as generative AI, the Clinic connects artists with the Center's network of copyright law expertise.

VISUAL ARTISTS' IMMIGRATION CLINIC

October 2023

Teresa Woods Peña was the keynote speaker for the October 2023 Clinic. She is an immigration attorney at the Woods Law Group who previously worked with the Vera Institute of Justice's Center on Immigration and Justice as well as the United Nations High Commissioner for Refugees. Teresa's presentation was a walkthrough of the O1-B artist visa application process, including the strength of different types of evidence as well as the timeline and fees.

Although the Visual Artists' Immigration Clinic was discontinued at the end of 2023, the Center continues to serve artists in this space by converting the Clinic to an annual workshop while continuing to share informational resources and organizing other programming.

For example, Patrick organized the workshop, *The O-1 Visa & the Impact Elections Have on Immigration*, which was led by Rakhel Milsetin of the Milstein Law Group. 11 people attended this workshop.



ARTIST-DEALER RELATIONSHIPS CLINIC

November 2023

Caitlin Dempsey was the keynote speaker for the November 2023 Clinic. She is an associate in Kurzman Eisenberg Corbin & Lever's corporate practice and art law practice. Caitlin explained the amendments to New York's Arts & Cultural Affairs Law and highlighted provisions in consignment agreements to pay attention to.

June 2024

ART & COPYRIGHT LAW CLINIC

April 2024

The proliferation of generative AI has prompted many artists to worry about their copyright and what actions can be taken to prevent tech companies from taking their work to train AI models. Based on requests the Center has received from artists as well as responses to Clinic feedback surveys, the Center launched the Art & Copyright Law Clinic in April 2024.

Juyoun Han, an attorney and partner at Eisenberg & Baum specializing in art law, civil rights, and digital technology. She represented artists in the 5Pointz litigation and in other landmark civil rights cases involving artists. Juyoun's keynote presentation provided an overview of the current copyright law landscape and discussed the impact generative AI is having on artists' rights.

32 participants attended this Clinic and 11 consultation sessions were conducted.

CLINIC PARTICIPANT FEEDBACK

After each clinic and clinic-themed program, the Judith Bresler Fellow sends out a feedback survey to participants. Responses to these feedback surveys are crucial as they help the Center improve its programming and stay attune to the wants and needs of the communities it serves.

While the clinic feedback is generally very positive, there are some areas of improvement. In particular, as the Center has expanded its reach, more and more clinic participants reside in states and jurisdictions where there is a lack of volunteer attorney coverage within the Center’s network. Reaching out to more attorneys in other jurisdictions will remedy this issue. Patrick started addressing this by creating and distributing volunteer interest surveys.

BEYOND THE CLINICS: ADVOCACY, RESEARCH & EVENTS

In October 2023, Patrick co-wrote with Atreya and Irina a response to the US Copyright Office's request for comments on AI and copyright. The comment advocated for copyright protections for artists while recognizing the potential for AI to be a tool for artists.

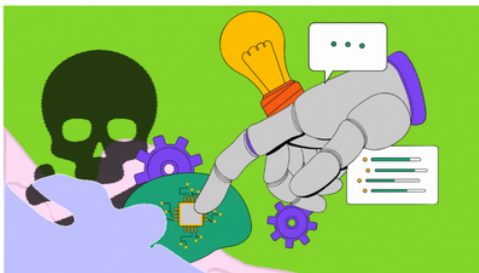

In March 2024, Patrick represented the Center as a speaker at the American Photography Archives Group's annual conference. Patrick's presentation covered copyright considerations for legacy and estate planning.

CLINIC-THEMED PROGRAMMING

In addition to the Visual Artists' Legal Clinics, Patrick was also responsible for organizing and hosting events related to the clinics themes—artist-dealer relationships, legacy and estate planning, and copyright law. Included below is a selection of events Patrick organized during his fellowship.



The *Legacy and Estate Planning Strategies for Artists & Collectors* workshop provided an overview of the estate and tax planning process. 49 people attended this workshop.



It's Not Personal, It's Business was a panel discussion about artists changing galleries, the impact this has on a gallery's business, and the legal disputes that arise when the artist-dealer relationship comes to an end. 48 people attended this panel.



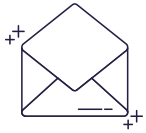
The Afterlife of Art was a panel covering posthumous moral rights and copyright. Patrick moderated a discussion with the co-editors and two authors of the book *Posthumous Art, Law and the Art Market*. 64 people attended this panel.



Exploring Copyright Ownership, Work for Hire & Generative AI was a workshop educated artists on copyright ownership in work-for-hire relationships and in the context of generative AI and appropriation art. 29 people attended this workshop.

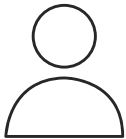
